General Notes

1. DISTRICT will remove all tape, gum, equipment, etc. from the hardwood floor surface.
2. CONTRACTOR will screen-back the full gym floor area using a high-speed buffer and 120 grit screens.
3. CONTRACTOR will tack the floor with treated tack towel to remove all dirt and residue.
4. CONTRACTOR will apply one liberal coat of Hillyard 450 Gymnasium Finish or equivalent MFMA approved, oil modified urethane gym finish to the floor. This coat of finish will provide a uniform coverage with no dull spots or lap marks.
5. Substitutions to the Hillyard 450 must be submitted for approval to DISTRICT prior to installation.
