Bids will be received at the office of Hollis + Miller Architects, 1828 Walnut Street, Suite 922, Kansas City, MO 64108, on or before 12:00 P.M. (local time), on Friday, July 2, 2021. No bids will be read out loud at the Bid Opening. Awards will be made within 60 days, and all bids will be taken under advisement. Bidders will receive an electronic format bid tab upon the request after approval by the District. *In addition to a hard copy of bid, a full electronic copy of bid submissions will be required to be considered for award. Electronic submissions are to be titled* "21013.10 - Bid Proposal for Furniture, Fixtures, and Equipment, Congress Middle School - Vendor Name" and delivered via flash *drive/thumb drive, CD, or other digital format.*

Each item specification indicates the total quantity required. Awarded vendors are responsible to place items in locations, as noted on the furniture floor plans.

If Bidder wishes to submit proposal for any or all furniture, fixtures, and equipment, do so by itemizing in the proper spaces on the accompanying Proposal Form. Quotations received on anything other than the provided Proposal Form will not be accepted.

The required unit cost being submitted should be based on NOT receiving all items. In addition to the required unit cost proposal form, 'All or None' bids per manufacturer may be provided. 'All or None' pricing must be shown on a separate proposal form noted as 'All or None Pricing'. Include all costs associated with freight, delivery, handling and installation within the unit cost of each item. Do not submit these costs as a separate line item in your bid. All items bid must be unit priced, extended, and totaled across Proposal Form. In the event unit cost of any item multiplied with the quantity does not agree with the entered total cost, unit price will prevail.

The Owner reserves the right to accept or reject any or all bids or portions of bids. The Owner reserves the right to increase or decrease the quantity of any item bid up to twenty-five percent (25%) until the end of bidder's contract without a change in the unit bid price. The Owner also reserves the right to not award contracts on every item listed in the specification document.

Do not include sales tax in the Bid. A tax-exempt number and certificate will be furnished to the contractor. Attach to your bid, a bond, certified check, or cashier's check on solvent bank in the

amount of five percent (5%) of bid offered and submitted. Same shall be retained until contract is awarded and returned to bidders when specified purchase order has been received and approved.

A Bidder may withdraw their Bid, either in person or by written request, at any time prior to scheduled time for opening Bids. Prior to time and date designated for the receipt of Bids, any Bid submitted may be modified. Written notice is required according to the following provisions:

• Written request must be contained in a sealed envelope marked "Modification of Bid" on project title and bid date.

After notification of award, provide Hollis + Miller all submittals necessary to complete final order entry for contracted items. Approval of purchase order does not relieve vendor/dealer's of responsibility for deviation from specifications unless they have, in writing, called attention to deviation at time of submission. It is also the vendor/dealer's responsibility to inform Hollis + Miller of any errors in schedules or purchase orders.

The Owner reserves the right to cancel any purchase order or portion of a purchase order if delivery schedule of an awarded item cannot be met.

GENERAL REQUIREMENTS

- A. Successful bidder agrees to furnish labor, materials and equipment necessary to provide furnishings as herein specified. Labor includes installing equipment and furnishings ready for Owner's use.
- B. Furnishings to be manufactured as specified. All equipment must meet the specification and description in dimensions, material, construction, design, and workmanship specified.

ACCEPTABLE MANUFACTURERS

- A. Manufacturer: Provide products of one specified manufacturer or a manufacturer that complies with the requirements.
- B. The proprietary name used to designate a particular manufacturer's model and style does not imply products of other manufacturers are excluded from bidding <u>unless noted</u>. Descriptions are used to establish quality and comparison. Submission of bids for alternate manufacturers should comply with or surpass the specification regarding quality.
- C. All materials and equipment must comply with applicable local codes. Notify H+M Architects of any discrepancies regarding product awarded to vendor's firm/company.

DESCRIPTION OF WORK

A. This specification covers furnishing and delivery, touch-up and repair or replacement of the items specified to the facility, unloading, assembling, leveling, completely installing and removing all crating, wrapping, etc., from premises. Storage, loading, and unloading at the job site is the sole responsibility of the successful bidder on items involved. Furnishings are to be distributed and placed in the individual rooms as designated in the floor plans.

- E. SUBMITTALS

A. <u>Samples:</u> Furniture, Fixtures, and Equipment List is based on items of design, appearance, and function desired. Specific items prescribed by trade names and numbers are to establish quality and comparison. Include descriptive literature on <u>all</u> items at variance with specific item. Dimensional sizes and function must be identical to each item specified so placement and function is assured.

All items bid, <u>other than specified manufacturer</u>, must outline in detail each item to indicate the product is equivalent to or surpasses the specified item. Submit photographs, cut sheets, warranty, and all necessary technical data for comparison purposes. Omitting this required information will nullify the bid on the substituted item. Include any limitations of color, grade, finishes, etc.

Bidders may be asked to submit a representative sample of their merchandise for comparison prior to making awards. These samples are to be production run, reflective of equipment proposed.

- B. <u>Documents for Submittal:</u> Furnish shop drawings and order entry documents in an electronic format and not hard copy. Make any corrections and resubmit revised prints until a final approval of submittals is obtained.
- C. <u>Order Acknowledgement:</u> Issue to Hollis + Miller, copies of manufacturers' acknowledgements indicating <u>all</u> product has been ordered by 60 days after contracts have been awarded.
- D. Furnish information/maintenance manuals written specifically for purchased equipment including descriptive drawings, cutaway pictures or views, performance curves, operating characteristics, and all other such data as required to establish a complete informational manual.
- E. Vendor/dealer is responsible to inform Hollis + Miller, in writing, of any issues relating to the availability, compatibility, wear, dimensional stability and serviceability of any item awarded to his firm/company.

SITE VISITS

A. Prior to placing orders with the manufacturers, each awarded vendor and lead installer is responsible to walk the site to confirm that all awarded product(s) can be installed at the locations as noted on plan, and all utility requirements are accessible to facilitate associated items.

Field verify sizes of doors, corridors, and rooms to confirm all furnishings can be installed in the designated areas. Items, which must be disassembled to fit, shall be ordered as such and reassembled at the site of the installation. Allow for and make special installation arrangements for items that cannot be disassembled.

It is the vendor's responsibility to inform the architect of any problem which would deter installation of an item, such as a dimension discrepancy, location of fire strobes, thermostats, or other obstacles.

B. After furniture orders have been placed, there will be a mandatory pre-install meeting at a time and date to be determined.

PRODUCT DELIVERY, STORAGE, AND HANDLING

- A. Delivery and installation is to occur between November 1-12.
- B. Delivery and installation of furnishings and equipment is to take place Monday through Friday, during <u>normal business hours (7:30am-4:30pm)</u>. Owner's approval is required to schedule installation at times other than the normal days or hours. Verify all delivery scheduling with Hollis & Miller prior to ship date.

No additional costs will be incurred by the Owner to complete an installation during "overtime" hours unless written district approval has been received by Hollis + Miller prior to work being completed.

- C. It is the responsibility of the Vendor/Dealer and/or Install Partner to place all items in the proper room locations from the delivery truck.
- D. No School District or Construction personnel will assist in unloading from the delivery trucks or in placing product in the facility
- E. Assume all furniture, fixtures, and equipment will be shipped in the manufacturer's standard knocked-down condition. Assemble all items prior to installation.
- F. The *Owner or Owner's Representative* will not be responsible or available for delivery verification. Each vendor will need a representative present at the job site if your firm or delivery company requires a signature.
- G. Awarded vendor/dealer is responsible for negotiating any freight damage claims regarding furniture, fixtures, and equipment.
- H. Storage of Materials, Equipment, and Furniture:
 - 1. Should conditions require any items to be delivered and stored due to site conditions, deliver in unopened containers, clearly labeled with the building's name, address, room number, manufacturer's name and container contents. Store in a safe, dry and clean location where directed. Do not open until needed for installation. Handling and installation of all materials in a manner that protects them from damage.
 - 2. When items are delivered before approval date, Vendor/ Dealer and/or Install Partner will supply storage space and absorb costs incurred for storage and for relocating to the site when facilities are ready. Maintain humidity and temperature of the storage site within an appropriate range to protect furniture, fixtures, and equipment from damage (warping, weathering, etc).
 - 3. In the event of damage, through faulty workmanship, shipping or handling, immediately make all repairs and replacements necessary to ensure approval of Owner.
- I. Handling Materials and Equipment:
 - 1. Notify Hollis + Miller of any damage to walls, floors, materials, or received items noticed at the time of installation and prior to placement of product. The Vendor/Dealer and/or Install Partner will be responsible for all costs/expenses to restore damaged property to original condition caused by installation personnel.

In the event the Owner incurs additional costs for professional services due to the Vendor/Dealer's errors and/or omission in ordering, scheduling or installing the awarded items, the Owner will deduct these additional costs from the Vendor/Dealer's contract amount. INSTALLATION/APPLICATION/PERFORMANCE/ERECTION

- A. Installation of Furniture, Fixtures, and Equipment:
 - 1. Delivery of FF&E will not be postponed because site work that may not have been completed. Use methods and materials to protect all floors throughout the building from tracking mud, dirt and other debris that is possible from outside elements.
 - 2. Protect building and all building finishes and materials from damage at all times.
 - 3. Take special precaution to protect flooring from soiling, or damage.
 - 4. Locate and install all furnishings and equipment in specified rooms identified on floor plans. Place items in rooms indicated in proper relation to building walls, with tops level.
 - 5. Supply all necessary labor, tools, utilities, and materials necessary to install furnishings, appliances and equipment, ready for use for completion of this work.


